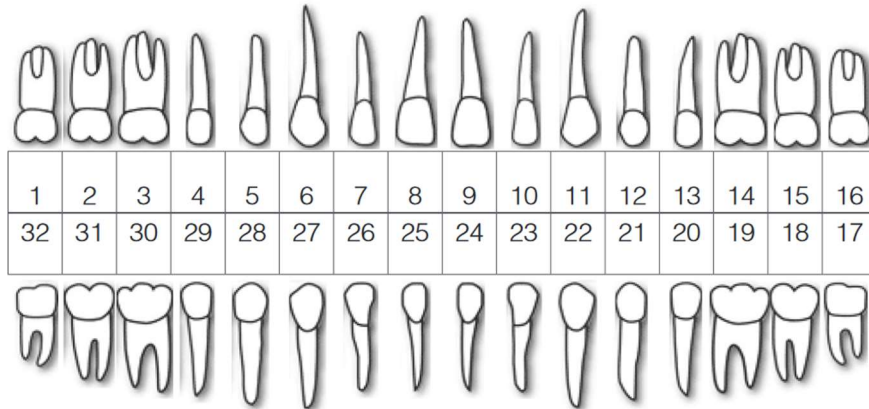

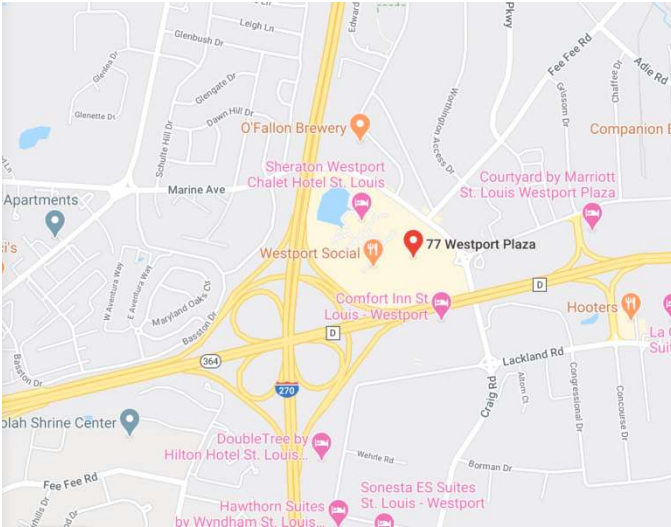

Directions To Our Office

FROM 

Take I-270 North from Hwy. 40 or South from I-70. Exit on the I-270 at Page Ave. east exit. Get in the far right lane. You will see an overpass and a green highway sign that says **Lackland Rd. and West Port Plaza Dr.** Take that exit. Stay in the far right lane and it will curve to the right. The first stop light is **Lackland Rd.** Turn right. Go through the next stoplight (about a block) at **Congressional Dr.** At the next stoplight you will turn **right on West Port Plaza Dr.** Get in the left lane and go over the overpass. At the next stoplight you will turn left into our parking lot at **Westline Ind. Dr.** There will be a McDonald's restaurant on the left. Our building is a red brick building next to the tall gold tower building which is **77 West Port Plaza.** We are on the third floor. Turn left when you get off the elevator and go all the way to the end of the hall to **Suite #367**

FROM Page Ave.

If you are approaching on Page Ave. westbound from Lindbergh Blvd., stay in the right lane after you pass Schuetz Rd. Shortly, you will see a green overhead highway sign that says **Westline Industrial Dr. and West Port Plaza Dr., ¼ mile.** Take that exit. At the stoplight, turn left on **Westline Industrial Dr.** At the next stoplight, proceed across **West Port Plaza Dr.** into our parking lot. There will be a McDonald's restaurant on the left. Our building is a red brick building next to the tall gold tower building which is **77 West Port Plaza.** We are on the third floor. Turn left when you get off the elevator and go all the way to the end of the hall to **Suite #367**
